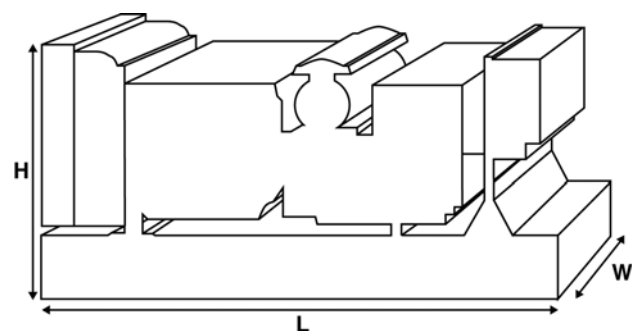
Standby Rating
