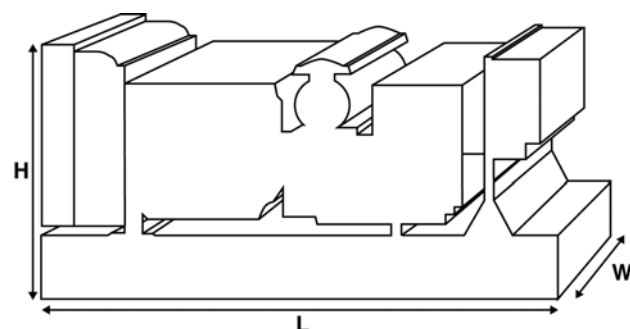
## Standby Rating
